Water mist

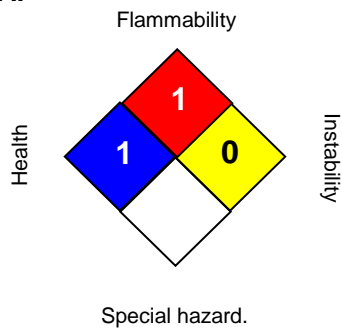
