TENNESSEE'S SENATOR COHEN TO SPEAK AT SMART-TECH. Tennessee Senator Stephen Cohen, major lottery proponent and Deputy Speaker of the Senate, will join us at SMART-Tech. You will want to hear all and meet the Senator.

MULTISTATE SUIT FILED IN OHIO. Some gambling opponents and church groups filed suit in Ohio saying that joining a multistate game violates the Ohio Constitution which permits only a lottery run exclusively by the State. The Governor's Office said that the filing will not impact the Ohio Lottery's decision on selecting a multistate. The Senate President added that the Governor could have even okayed the plan without legislation.

DISMISSAL IN CALIFORNIA. That lawsuit against the California Lottery for selling tickets after the top prizes was dismissed. The issue, though, has recently surfaced or resurfaced in Arizona and Ohio with news reports on the subject..

GREAT WEEK FOR SOUTH CAROLINA. Lots of scratching' going on in South Carolina during the Lottery's launch week with estimates that nearly \$20 million in tickets were sold at 3,300 retail locations. Three million players won \$10.8 million and the most popular game featured the Lottery's logo. Per cap was \$4.74.

NEW GAMES FOR VIRGIN ISLANDS. The Virgin Island Lottery will add Caribbean Lotto and several other games to its lineup provided by Antigua-based Caribbean Lottery, Inc. The VI Lottery has been battling revenue problems and lots of competition from the Puerto Rico games and expects the new games to bring in \$10 million a year in profits

(Caribbean Lottery gives 10 percent of gross receipts to the Lottery and the Lottery gives five percent to the government). The parent company of Caribbean Lottery is Leeward Island Holding Company which runs games on numerous beautiful islands.

LOOKING TO JOIN UP. Speaking to a Virgin Islands legislative committee, the CEO of Caribbean Lottery Services, said joining a mainland multistate game would bring great benefits to the Islands, visited by nearly two million a tourists a year.

IT'S ALL ABOUT MONEY. Lottery proponents in North Carolina, the strongest being Governor Mike Easley, are watching the money float across the borders into Virginia, Georgia and now South Carolina. They say it is a lot, opponents say not so much. Look for the battle to continue as legislation for a North Carolina Lottery is reintroduced as it has been for the sixth time in seven years.

TAIWAN ON-LINE UP AND SELLING. Taiwanese Lottery players, for the first time playing on a online system, seem to like the game with nearly 1.7 million tickets sold on the first day at 2,700 retailers (expecting about 5,000 eventually). The game is six of 42 with revenue going to health insurance, pension funds and construction projects. First drawing tomorrow. The Lottery launch marks the end of an 11-year suspension of lotteries in Taiwan after a former premier ended decades of play, saying lotteries increased the crime rate.

LEADERSHIP AWARD TO GLEASON AND GIBBS.

Kentucky Lottery Corporation CEO Arch Gleason and COO Marty Gibbs were awarded the 2001 Louisville Society of Human Resources Management Leadership Award which recognizes exceptional leadership in advancing the strategic importance of human resources in an organization.

ACTING GOV HAS AN IDEA. Massachusetts Acting Governor Jane Swift's office will do an analysis looking at the possibility of reducing the Mass Lottery's payouts, wanting more profit. As all know, the very successful Massachusetts Lottery has one of the highest per caps in the Country. The State Treasurer, in charge of the Lottery, does not agree with the idea.

TWO NEW APPOINTMENTS TO NM BOARD. Filling two unexpired terms, William Bonds, a CPA and Eugene Zamora, a lawyer, have been appointed by New Mexico Governor Gary Johnson to the New Mexico Lottery Authority Board of Directors.

MARYLAND. The Maryland Lottery is bringing back its popular Bonus Match 5 on February 4. Draws seven days a week and a top prize of \$50,000 for WMS BELOW ESTIMATES FOR 2ND QUARTER. more money. Three plays for \$2 and four for \$3.
