MORNING REPORT

BUSH NAMES NEW FLORIDA HEAD. Florida Governor Jeb Bush named former state Film Commissioner Rebecca Mattingly to head the Florida Lottery. Former lottery secretary David Griffin is now serving as executive director of the transition team that Bush appointed to review each of the state's major agencies.

OHIO RFP. The Ohio Lottery Commission has released a RFP to provide for the agency's creative production services. The Ohio Lottery intends to award multiple contracts to vendors to provide these services. The selected vendors' primary responsibility will be to develop advertising programs and provide marketing services following direction provided by the Ohio Lottery. Vendors will be placed on a monthly retainer and will be expected to submit creative concepts for Lottery advertising campaigns. Vendors submitting the concepts chosen for use will be compensated based on a percentage of the job cost. These programs include performing marketing research, designing and developing creative concepts and ad campaigns, producing TV, radio and print media spots, and creating POS materials. Responses are due back March 20, 2003. The contract period runs from July 1, 2003 to June 30, 2005, with two, two-year renewal options.

TEXAS WINS TELLY. The Texas Lottery Commission won three prestigious awards for its in-house video productions. The "Latin Lotto Scam Public Service Announcement" earned the agency a Telly Award. This was the agency's first-ever entry in this national competition. The Telly has become one of the most sought-after awards in the TV, commercial and video industry. The other two honors were Communicator Awards: a "Crystal Award of Excellence" for its "Retailer Town Hall Video," and an "Award of Distinction" for the "Latin Lotto Scam Public Service Announcement."

CA TEAMS UP WITH NBA. The California Lottery and the NBA teamed-up to offer sports fans a new way to

play their way to the NBA Finals. Sports fans can take a shot with the new \$2 Scratchers® game filled with the high excitement and energy of NBA basketball. The Lottery's Scratchers tickets feature teams like the Sacramento Kings and the Los Angeles Lakers and incorporate bonus prizes such as game tickets, road trips, all-star experiences, plus packages of high quality, genuine NBA collectible merchandise.

CT AG PUTS CD-GAME ON HOLD. Connecticut Attorney General Richard Blumenthal has asked the Connecticut Lottery to hold off on introducing its new interactive lottery game, because Blumenthal is concerned the game, Treasure Tower, comes very close to Internet gambling. Another concern is the fear that the game could be construed as a video lottery, which might be prohibited by state law.

MUSGRAVE HEADS NEW GAMING DIVISION. West Virginia Senate Finance Committee members amended a bill (SB153) to ensure that John Musgrave, the West Virginia Lottery Director, will be in charge of a new gaming division that brings the lottery, dog and horse racing, and charitable bingo under a single agency.

KY LAUNCHES SECOND HARLEY INSTANT. Harley-Davidson® is celebrating its 100th Anniversary and the Kentucky Lottery is helping celebrate with a \$5 instant ticket. Players can win a 100th Anniversary Harley-Davidson motorcycle instantly or through a second-chance promotion.

OK LOTTERY BILL DEFEATED. The Oklahoma House defeated a plan to put a state lottery to a vote of the people. Representative Ron Kirby of Lawton managed to keep the measure alive on a procedural move, which could cause the House to reconsider the issue in a few days.

EHRLICH REVISES VLT PLAN. Maryland Gov. Robert L. Ehrlich Jr. revised his VLT plan by increasing the share of the projected \$1.5 billion gambling jackpot that would go to racetrack owners and cutting the percentage earmarked for public education. Ehrlich also slashed by two-thirds the licensing fees that he wants to charge tracks, and increased the number of machines allowed at tracks to 11,500. The Governor hopes the new plan will gather support in the General Assembly.

CT LAUNCHES UNDERAGE PSA. The CT Partnership for Responsible Gambling will launch its first underage gambling PSA to coincide with the state's second annual "Gambling Awareness Week," beginning March 10. The 30-second spot, produced by the CT Lottery, encourages parents to talk about gambling issues with their children, before problems occur. Reminding adults that "underage gambling is illegal," the spot advises "if you don't talk with your kids about gambling, the odds could be against them."

CAMELOT GOES INTERACTIVE. Camelot launched a new online interactive service allowing players to

purchase National Lottery tickets over the Internet, on TV and cellular phones. The five new interactive Instant Win Games start at just 25p per ticket and are available for play between 7:00 am and midnight seven days a week with a maximum instant jackpot of £10,000. Players must be aged over 16 to play and resident in the UK or the Isle of Man. Plans include the launch of Lotto online later this year.

SAZKA GOES AHEAD WITH STADIUM. SAZKA has moved ahead with plans to build the Hala Sazka ice hockey stadium despite fears in recent weeks that the project could be halted for lack of financial backing. Apparently the company signed a loan agreement with a consortium of banks on February 18 that will allow it to complete the 20,000-capacity arena in time for the 2004 World Ice Hockey Championships.

FIXED-ODDS RECORD IN GREECE. Greek fixed-odds betting registered an increase of more than 15% in 2002, which was another record year. With sales of betting products topping 1.5 billion, Betting Company maintains its leading position in the fixed-odds betting and bookmaking business, worldwide. Betting Company is a member of the Intralot Group.

MULTI-CHANNEL GAMING AT NORSK TIPPING.

Norsk Tipping launched its wide range of games both on the Internet and as a test pilot on mobile telephones 1 2002. In the year ahead, customers will also get the opportunity to make their bets via their digital television, and it is also very likely that the government will give Norsk Tipping the exclusive right to run slot machines in Norway.

THAILAND LOOKS TOWARD JULY LOTTO

LAUNCH. The Director of Thailand's Government Lottery Office announced that approximately 3,000 lottery terminals will be installed by July. The Director said that eventually there would be 12,000 terminals installed nationwide. The terminals would sell two and three-digit tickets.

COMPANY ANNOUNCEMENTS

IGT INCREASES SHARE REPURCHASE. IGT's Board of Directors increased the company's share repurchase

authorization by 7.4 million shares to a total of 10.0 million shares.

INTRALOT REPORTS YEAR-END RESULTS. Intralot achieved a 20.3% growth in its pre-tax profits, 13.3% in sales (to 319.3 m) and 18.2% (87.1 m) in EBITDA, for the year ended December 31, 2002. Intralot achieved to sustain a high growth in its revenues, operating earnings, earnings per share and to maintain its ability to generate considerable operating cash flow.

SGI REPORTS 4th QUARTER AND YEAR-END RESULTS. For the fiscal year 2002, Sci-Game's revenues increased to \$455.3 million compared to \$440.2 million in 2001, and EBITDA grew to \$123.7 million from \$105.1 million in the prior year. EBITDA for the 2002 year, adjusted to exclude the costs attributable to the Pick Six matter, increased by 19% to \$124.7 million from \$105.1 million for the comparable period in 2001. Net income in 2002 before the non-cash preferred stock dividend was \$52.1 million or \$0.65 per diluted share. This unusually high level of net income is primarily attributable to the inclusion in the fourth quarter of 2002 of an income tax benefit of approximately \$42.4 million from the recognition of net operating tax loss carryforwards. Financial results for the fourth guarter ended December 31, 2002 show revenue and EBITDA for the fourth quarter of 2002 increased to \$118.9 million and \$30.7 million. respectively, from \$108.4 million and \$24.8 million.

COMPANY. GTECH has entered into an agreement to purchase a controlling equity position in PolCard S.A., the leading debit and credit card merchant transaction acquirer and processor company in Poland, with a nationwide retail network of 34,000 point-of-sale terminals and relationships with many of the country's leading card-issuing banks. GTECH, partnered with two funds managed by Innova Capital Sp. z o.o., a Warsaw-based private equity investment advisor, will acquire 99.7 percent of the outstanding share capital of PolCard for a total purchase price of approximately \$60 million. GTECH will hold a 62.8 percent stake in PolCard and 36.9 percent will be held by Innova.

TELECOM EXTENDS HASBRO LINE. TeleCom Productions announced a contract with Hasbro Classic Games which allows TeleCom Game Factory to use Hasbro's Life®, Risk® and Twister® names and logos in the development of lottery instant scratch games. The agreement grants TeleCom Game Factory exclusive use featuring names, characters, images, trademarks, logos, game pieces, play styles and other imagery associated with the Hasbro games.
