MORNING REPORT

OK SENATE APPROVES LOTTERY VOTE. The Oklahoma Senate voted 26-19 in favor of a bill to submit Gov. Brad Henry's education lottery to a statewide vote. The bill passed in the House of Representatives earlier in March, but must return for a vote due to Senate amendments.

MARYLAND SENATE APPROVES VLTs. The Maryland Senate voted 25-21 in favor of VLTs at tracks. The approved plan calls for 3,500 Lottery controlled VLTs at Pimlico, Laurel and Rosecroft. Lease applicants would be required to pay a one time application fee of \$5 million, and each operator would be required to invest at least \$150 million in construction and related costs, provide at least 500 full time jobs, and offer at least 15% ownership to minority businesses (or 10% if they hold more than one license). The licenses are good for 15 years, at which time they must reapply to the Lottery Commission. A \$390 fee per machine is to be paid by the operators into a Compulsive Gambling Fund. Each machine is expected to generate \$398 per day.

ND SENATE APPROVES LOTTERY WITH A FEW CHANGES. The North Dakota Senate voted 41-4 in favor of a bill to regulate the proposed state lottery. The House has already approved the bill, but will have to revote in order to approve Senate amendments. The Senate version doubles the amount of money set aside for addiction, puts lottery regulation and directorappointing powers in the attorney general's office and allows for a purchasing age of 18.

MISSOURI SHOWS AMERICAN MUSCLE. Missouri Lottery Pick 3 players are given an extra reason to play with the Lottery's "American Muscle" promotion, March 30 through April 26. The four-week promotion will offer prizes like a grand-prize 2002 Ford Thunderbird and \$500 cash, two first-prize 2003 Ford Mustang GT Coupes and \$500 cash, 200 cash prizes of \$598 and 2,000 Pick 3 T-shirts. Starting March 30, players will

receive an entry slip along with their tickets when they make a minimum \$3 single ticket Pick 3 purchase for the current draw. Players can enter online, at entry boxes found at retail locations, or by mail.

NJ LOOKS AT VLTs. New Jersey Gov. James McGreevey is giving a long hard look to VLTs at state racetracks. It's estimated that 10,000 VLTs at three racetracks could raise as much as \$500 million a year. McGreevey has appointed a commission to evaluate the merits of video lottery and report findings by May 4.

REQUEST FOR 500 MORE WV MACHINES. A request came in for another 500 slots at West Virginia's Mountaineer Race Track and Gaming Resort. The track currently operates 3,000 machines. While a Lottery spokesperson said that it appears the market can handle the additional machines, no word has been given as to whether the request will be granted.

VANCOUVER BC TRACK REQUESTS SLOTS. BC's Vancouver city council has asked for a report on the feasibility of slots at Hastings Racetrack. Slots are currently not allowed, and Vancouver has not looked favorably on past attempts at expanded gambling.

FL PROPOSAL WOULD REDUCE SCHOLARSHIPS.

A budget crunch and rising student numbers that could send scholarship needs as high as \$800 million within ten years has led Florida House Republicans to pushing a bill that would raise exam requirements and cut the number of scholarship applicants. Last year FL gave out \$164 million in scholarship money, and next year the number is expected to rise to \$250 million. The bill is expected to face tough opposition from Democrats.

MT INTERNATIONAL BILL APPROVED. Montana lawmakers have endorsed a bill allowing the Lottery to participate in international lotteries. The Senate voted 24-22 in favor of HB 165, which keeps the state eligible for Powerball should a foreign country enter the game.

A TRIO OF BILLS IN PA. Pennsylvania Senate Democratic Leader Robert J. Mellow has introduced a trio of bills aimed at beefing up the state's Lottery profits. SB405 would authorize the Pennsylvania Liquor Control Board to operate and maintain lottery machines in liquor stores and would require at least one machine per store. SB406 would require retailers to post a minimum bond of \$10,000 per year. SB407, would create the State Lottery Oversight Board as an independent function that would oversee and evaluate the lottery's administration and operation.

NM BILLS PASS. A couple of gambling bills passed in New Mexico recently. One would permit the state to continue with the Powerball lottery if Mexico joined the game. Another provides for a study on the effects of gambling, and requests that the Lottery Authority help fund the study.

QUEBEC SIGNS VISIBILITY AGREEMENT. Tourisme Québec and Loto-Québec have announced the conclusion of a visibility agreement with Interbox in conjunction with the next WBC world championship fight scheduled for April 5, 2003 in Leipzig, Germany. The super middleweight bout will pit Québecer Éric Lucas against German fighter Markus Beyer. The agreement with Interbox calls for the appearance of the Bonjour Québec signature and Casino de Montréal logo on all the clothing and sweat apparel worn by boxer Lucas and his team, as well as their clear visibility at training locations and during the live broadcast.

FREE KENO IN WV. The West Virginia Lottery mailed out coupons for a free round of Keno. The Lottery Commission sent out 213,000 free Keno coupons, good for one free game. The free coupons were in envelopes that said state players must be at least 18 years old. The lottery is also offering free Keno coupons for people who did not get the mailing, but who live within a five-mile radius of a Keno location in urban areas or within a 15-mile radius of a Keno location in rural areas. The Lottery Commission is offering one per household.

IRELAND INQUIRES ABOUT EUROMILLIONS. The Irish National Lottery is in discussions with Camelot, Loterias y Apuestas del Estado and La Francaise de Jeux about joining Euromillions, the new European multi-jurisdiction lottery. The three organizing lotteries have set a limit on the number of lotteries that can join.

POLAND SAY YES TO GAMBLING EXPANSION.

Polish lawmakers have passed a gaming amendment allowing video-keno, telebingo and low-payout slot machines. The proposal also sets new rules for taxing these games. The amendment also allows companies from the EU to run games-of-chance and betting.

MIFAL HAPAIS SHOWS SUPPORT FOR TROOPS.

Mifal Hapais, the Israel National Lottery, has decided to encourage the Allied Forces in their war efforts and the American people with a special gesture. All of its 2500 points of sales all over Israel were decorated this week with a poster, showing the American flag and the slogan, 'We are with the Americans.' A year ago, Mifal Hapais had issued an instant card titled America, which is still on sale.

GROSS SALES UP AT SVENSKA SPEL. Svenska Spel, the Swedish Lottery, saw gross sales jump by 15.4%. Net sales of 14.5 billion SEK (1.6 billion Euro) remained about the same as in 2001, due to the fact that more players are going for games with a higher payout. The game with the highest increase was the VLTs, up 44% with gross sales of 6 billion SEK.

COMPANY ANNOUNCEMENTS

SGI AWARDED PERU CONTRACT. Scientific Games has been awarded a contract to supply an on-line AEGIS® lottery system to International Lotto Corp., S.A.

(ILC), a Peruvian Company installing the first "Real-Time and On-Line Electronic Lottery" in the Republic of Peru. The initial term of the contract is fifteen years with an option to renew for an additional fifteen-year period. The company estimates that the new contract could be worth approximately \$30 million over the initial five-year period. The contract also calls for the Company to provide 2,500 EXTREMA® terminals, project implementation support and ongoing project oversight and consulting services. The start up date for the new lottery is expected by early summer of 2003.

AUSTRIA AND EDITEC COOPERATE FOR NEW MACHINE. WinTV, the Drawing Department of Editec SA, has delivered three new machines for ToiToiToi, the latest game of the Austrian Lotteries. The principle of this daily TV game is to draw a 5-digit number and a symbol. To do that, Editec and the Austrian Lotteries have developed a slot-type drawing machine which generates the daily number. The machine was aimed at fitting within the very high tech studio environment of the game.

INTERLOTT AWARDED OHIO. Interlott Technologies has been named the selected vendor for a new contract with the Ohio Lottery to provide ITVMs and related services. The contract is the first ITVM contract based on a percentage of sale of instant tickets and will utilize Interlott's new Advanced Communication System to track sales from the ITVMs. Interlott has provided to the Ohio Lottery since 1992. In related news, Interlott has received a purchase order from the Hoosier Lottery for an additional 200 eight-game PTVMs to be delivered in May 2003. In August 2002, Interlott announced the lottery had purchased 500 PTVMs. Indiana also leases nearly 700 ITVMs.

NETKIT WINS CONTRACT IN UK. NetKit Solutions has been selected by Global Crossing to provide network access equipment and support for the ISDN-based UK National Lottery network service. NetKit's digital access platform, Nevada, will replace the X.25 leased line and VSAT-based networks. NetKit also will supply to Global Crossing its suite of operations, administration, maintenance and provisioning back office application servers for broadcasting new gaming software to more than 25,000 lottery terminals as new releases become available.

SCHAFER HONORED. Schafer Systems was named lowa/Nebraska ESOP Company of the Year. Eight Schafer Systems employee owners received the award on behalf of the company. The basis for this award was the unique "ownership culture" of Schafer Systems and its subsidiary, Connect-A-Dock Inc. Receiving the lowa/Nebraska Chapter Company of the Year Award has placed Schafer Systems in competition for the National ESOP Company of the Year competition.
