PROOF OF NOTICE DECLARATION

California Civil Code Section 8118

Per California civil code the undersigned served copies of the Preliminary Notice form for Public Works projects:

- By personally delivering the notice to the person or the persons to be notified
- By registered, certified mail, or express mail; or overnight delivery by an Express Service Carrier
- By leaving the notice and mailing a copy in the manner provided in Section 415.20 of the Code of Civil Procedure for service of summons and complaint in a civil action

As evidenced by the following:

- Attached documentation provided by the United States Postal Service showing that payment was made to mail the notice using registered, or certified mail, or express mail
- Attached documentation provided by an express service carrier showing that payment was made to send the notice using an overnight delivery service
- Attached return receipt, delivery confirmation, signature confirmation, tracking record, or other proof of delivery or attempted delivery provided by the United States Postal Service, or a photocopy of the record of delivery and receipt maintained by the United States Postal Service, showing the date of delivery and to whom delivered, or in the event of non delivery, by the returned envelope itself
- Attached tracking record or other documentation provided by an express service carrier showing delivery or attempted delivery of the notice
