PRODUCT DESCRIPTION

Specialist wet-work cream to defend against prolonged or frequent contact with water or water-based substances. Perfume-free and dye-free.

WHERE TO USE

Work places with prolonged exposure to water and water-based contaminants (such as water-based cooling lubricants, detergents, cleaning agents, disinfectants, salts, mixed cement and fertilizers) and frequent hand washing requirements. Can be used with gloves or PPE.

INSTRUCTIONS FOR USE

- Apply 1mL to clean and dry skin before starting each work period and after washing hands
- Rub on all areas of the hands, including between the fingers and around the fingernails

NB: Skin exposure to potentially harmful substances and environments should be avoided through the implementation of safe working practices and the use of appropriate Personal Protective Equipment. Where skin exposure cannot be avoided, it is recommended to use an appropriate skin defense cream as part of a complete skin care program to help promote healthy skin condition.

COMPATIBILITY TESTS

Glove Compatibility Test

In independent testing, the use of Stokoderm® Aqua ^{PURE} in combination with reputable latex, vinyl and nitrile gloves does not have any deleterious effect on the glove tensile properties using EN 455-2:2009 test methodology.

Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with EN ISO/IEC 17025, the use of Stokoderm® Aqua ^{PURE} in rubber production process does not influence the cohesive strength of rubber.

Sanitizer Compatibility Test

The compatibility of Stokoderm® Aqua ^{PURE} with alcohol-based hand sanitizers was tested using a modified EN13727 test protocol. Results show that Stokoderm® Aqua ^{PURE} does not negatively affect the efficacy of alcohol based hand sanitizers against *Ps aeruginosa*, *E coli*, *S aureus* and *E hirae*.

PRODUCT SAFETY ASSURANCE

Skin Compatibility Test

Independent dermatological tests conducted to assess the skin compatibility of the product using voluntary test persons in occlusive, 69 consecutive hour application models, shows the product to be non-irritating in use.

Toxicological Approval

The product has been assessed by an independent toxicologist and has been declared to be safe for use on the hands, face and neck of adults aged 16 and above.

Skin Hypoallergenic Risk Assessment

The formulation has been assessed by an independent toxicologist to be formulated in such a way as to provide either minimal or no risk of provoking allergic skin response and thus meets the requirements for being described as 'Hypoallergenic' (Delphic Solutions Ltd, UK).

SUITABLE FOR USE IN FOOD HANDLING AREAS

Stokoderm® Aqua ^{PURE} as per usage instructions, does not influence the quality and safety of foodstuffs.

The product has been assessed using the HACCP hazard analysis methodology. The following critical control points were identified and are controlled as follows -

1. Impact on smell and taste of foodstuffs - The formulation has been independently tested according to 'Sensory Analysis - Methodology - Triangle Test EN ISO 4120:2007' and proven to not have the potential to taint food.
2. Possible toxic effects of ingredients - An independent oral toxicological evaluation was performed and concluded that any foodstuffs which may contain trace amounts of the product, are unlikely to cause any adverse toxicological effects.

EFFICACY TESTS

Skin Hypoallergenic

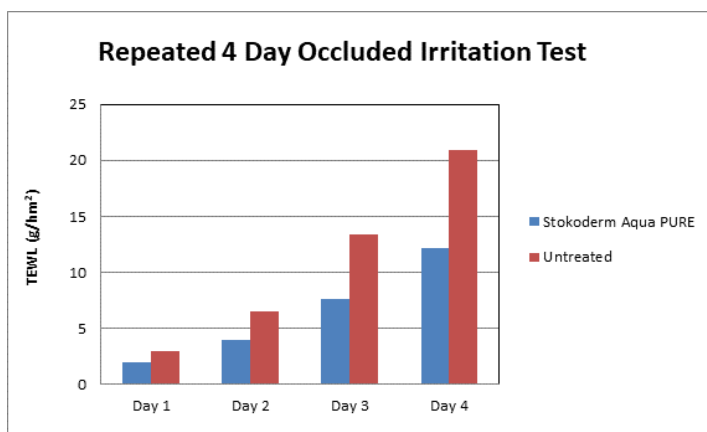
The perfume-free and dye-free formulation did not demonstrate a potential for eliciting dermal sensitization after conducting an independent 6 week Human Repeat Insult Patch Test (HRIPT).

Allergy sufferers should always refer to the ingredient list before using the product.

Barrier Property Test

Repeated Occluded Irritation Patch Testing using healthy volunteers was conducted using a water soluble substance (Sodium Lauryl Sulphate) applied twice per day for 30 minutes (once in the morning and once in the afternoon) over 4 days.

Results (Figure 1) show Stokoderm® Aqua ^{PURE} significantly reduces the Trans Epidermal Water Loss (TEWL) compared to untreated skin.
