- Add a little water and continue washing.
- Rinse with plenty of water and dry thoroughly.

For extra heavy duty contamination, for instance from waste, mineral and lubrication oils, graphite, metallic dust and carbon black, which can only be removed with a solvent-containing hand cleanser.
